- with reference to the Addendum to the abovesaid Agreement;
- with reference to the rules and regulations of CIHEAM Bari, and in agreement with the Polytechnic University of Bari -DICATECh

ISSUES

the following selection notice for the awarding of the sub-unit assignments listed in the teaching plan (see annex 1) for the second level Master in "Sustainable water and land management in agricultural ecosystems", Academic Year 2024-2025, jointly delivered by the Polytechnic University of Bari -DICATECh and CIHEAM Bari.

The teaching sub-units can be assigned to professors, lecturers as well as experts with high and documented qualifications in the topics that characterize the sub-units.

Each sub-unit is usually organized on a weekly basis with lectures taking place from Monday to Friday for 6 hours/day (from 9:00 am to 1:00 pm and from 3:00 pm to 5:00 pm) for a total of 30 hours.

According to the rules of the 2nd level Master in "Sustainable water and land management in agricultural ecosystems", 1 ECTS/CFU is conventionally composed of 15 teaching hours divided into lectures, exercises, project works and learning tests, therefore each sub-unit assigns 2 CFU.

The honorarium for the teaching assignments is established according to CIHEAM Bari internal rules, policies and regulations, is calculated on an hourly basis and is inclusive of taxes, duties, and any further charges. The honorarium, which is fully covered by the *ad hoc* budget allocated for this purpose, is paid upon completion of the scheduled hours and validated by the CIHEAM Bari officer in charge.

Applications must be sent to the following email address *segreteriamasterW&L@iamb.it* by October 25th 2024 at 12:00 p.m. Candidates whose applications are received beyond the deadline indicated above will be automatically excluded from the selection procedure.

CIHEAM Bari is not liable for any incorrect, inaccurate, incomplete, damaged, lost, delayed, misdirected or intercepted entries, or for any incorrectly submitted or received applications, unreadable, damaged, lost, delayed,



misdirected or intercepted. In addition, CIHEAM Bari is not liable for applications that, for any reason, are not received, or electronic or other communications that are delayed, or other technical problems related to the submission and uploading of applications.

The candidate must submit a specific application using the template reported in <u>annex 2</u>.

The candidate must enclose the following documentation to the abovesaid application, duly filled in and signed:

- a. CV with indication of professional and scientific activities and publications related to the assignment.
- b. Detailed list of documents and qualifications useful for the selection purpose. By qualifications we mean, for example, educational qualifications, professional qualifications, specialization qualifications, training experiences in Med context, etc.
- c. Proposal of the syllabus.
- d. Photocopy of a valid ID.

The Scientific Council of the Master (CTS) will evaluate the scientific competences of the candidates based on the following criteria:

- a. Qualification of the candidate in the field of the requested teaching sub-unit
- b. English language skills

Once the selection procedure has been completed, the Scientific Council ranks the suitable candidates per each teaching unit. The ranking is valid exclusively for the academic year 2024/2025.

At the end of the procedure, the CTS has the duty to transmit the results to the Master Secretariat that will:

- a) prepare and send the letter of appointment for teaching signed by the director of CIHEAM Bari.
- b) prepare the teaching contract with the specification of the teacher's obligations.
- c) provide the lecturer with the credentials to access the ESSE3 university platform where the lecturer has the contractual obligation to upload the teaching program, the class register and the results of the final tests.

The lecturer who is entrusted with a teaching role assumes the status of "contract professor" only for the period in which the activity is carried out. The lecturer is required to prepare the examination test to deliver at the end of the teaching sub-unit and to evaluate the students work with a mark expressed in hundredths.

CIHEAM Bari provides insurance coverage for accidents and civil liability towards third parties.

The personal data provided by applicants will be collected by CIHEAM Bari and processed for the purposes connected to the selection procedure. By submitting their application, the applicants explicitly and fully accept and authorize CIHEAM Bari to process their personal data for the management and monitoring of the selection procedure, in compliance with the principles of lawfulness, fairness and confidentiality requirements, in recognition that on 5 July 2019 the CIHEAM adopted the "Security of the Information and Personal Data Protection Policy", inspired by the same principles stated in the EU Regulation 679/2016 – General Data Protection Regulation and subsequent amendments and additions.
