3. The seedling must be free from any diseases or pests, especially root rot, gummosis, nematodes, crown gall disease, and bark or wood borers.
4. The seedlings should be planted in bags with a capacity of 5 liters.
5. The grafting point must be at least 15 cm above the soil surface in the bag.
6. The height of the seedling above the grafting point should not be less than 50 cm.
7. The thickness of the seedling should not be less than 10 mm, measured 10 cm above the grafting point.
8. The scion thickness of the seedling should not be less than 8 mm.
9. The union between the rootstock and the scion must be good and compatible, without excessive swelling.
10. The seedlings should be upright and straight.
11. The trunk must be free from wounds, protrusions, and knuckles.
12. The root system should be healthy, well-developed, not twisted, and proportional to the size of the seedling.
13. A health certificate from the laboratory must be attached, proving the seedlings are free from crown gall disease.
